



**Mines Innov8x Studio Membership Application:**

We are looking for high-potential affiliated team members, startups, and idea generators that will advance technologies and solutions that can have real world applications in industry. The Innov8x studio is a workspace that allows participants a place to work, connect, strategize, build, prototype, and test ideas and reiterate and work towards a solution that can be taken to market.

Currently, there is no fee charged to Mines students nor employees, however a signed Studio Agreement is required by each team member. In June and December of each year, the progress of each team will be reviewed. If positive progress on the project is not being made, membership termination for utilization of the space is possible to allow others access to the studio. Ideally, your participation begins at the start of either the fall or spring semester, continues for the 16-week term, and then terminates at the end of the semester.
